EU DEFORASTION REGULATION *latest news*

ELO welcomed the Commission's proposal to extend the implementation period of the EU Deforestation Regulation (EUDR), since it is crucial to ensure that it is implemented under the right conditions, including adequate phase-in time, to be both effective and feasible. According to the commission, "it will take one year, no more to adopt the technical criteria for implementation, and that reopening the regulation was an exceptional step due to the complex nature of the legislation". Now we call on the co-legislators to make a swift decision to help reduce the legal uncertainty faced by operators. Following the positive Council position, the Parliament is likely to go for "urgency procedure" and approve the amendment to delay as soon as possible, even if there are still voices asking for it to be rejected.
